**PLEASE NOTE MARCH 15, 2019 DEADLINE FOR PRE-REGISTRATION APPLICATIONS.**

The staffs of Fort Frederick State Park and the Friends of Fort Frederick are pleased to announce that we will host the 25<sup>th</sup> annual 18<sup>th</sup> Century Market Fair April 25 - 28, 2019. The fair represents eastern North America from 1730 through 1790. The Fair is open to sutlers, traders, street vendors and entertainers as well as individuals, groups, military units and American Indians portraying the appropriate time period and geographic area.

Enclosed is a pre-registration application form along with basic event information. Enclosed is a Pre-Registration form along with Event Information / Regulations and Trade Rules. **Please read all information carefully. Your signature on the Pre-Registration Form indicates that you have read and understand all event information and regulations and will abide by them.**

Note the following in particular:

- ▶ **Pre-Registration:** Camper pre-registration applications must be postmarked by March 15, 2019. You will be notified by postcard of receipt of your application. Receipt and acceptance of the enclosed application serves as your pre-registration for the event.
- ▶ **Late registrations:** No late pre-registration applications will be accepted, nor will faxed or emailed applications. All pre-registration applications received with postmarks after March 15, 2019 will be returned; you may use them to register and pay at the gate.
- ▶ **Non-pre-registered participants:** Campers who are not pre-registered may still attend the event but will be charged an additional fee of \$10.00 per person to register at the gate.
- ▶ **Registration hours:** Please note the Gate and Registration hours listed on the Event Information sheet. Gate hours will be strictly enforced. Please plan accordingly. All participants must register on site at the gate prior to setting up or proceeding to their camp. Sites to set up your camp are on a 'first come - first serve' basis.
- ▶ **Volunteers:** Volunteers must contact The Friends of Fort Frederick either via email at [info@friendsoffortfrederick.info](mailto:info@friendsoffortfrederick.info) or George Michael, Volunteer Coordinator, at [gfmichael46@gmail.com](mailto:gfmichael46@gmail.com) (preferred) or leave a message with Bob Yetter at 301-569-0401. Requests to volunteer must be received by **April 1, 2019**. Individuals who volunteer to help with event setup and/or tear down may set up their camp as early as Monday, April 22, but no earlier. **No** early arrivals are allowed unless you are volunteering and have received confirmation of that. Volunteer opportunities include: road watch, auction, registration, HQ tent, set-up, tear-down tasks or any combination thereof. Once requests are received, the information will be directed to the respective coordinator. Please see the volunteer information posted on the website for additional information.

All proceeds from this event will be used by the Friends of Fort Frederick to support activities at Fort Frederick State Park. We look forward to another successful Market Fair in April 2019.
